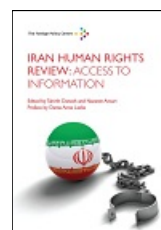

It argues for greater UK, EU and Western engagement in Armenia but that increased incentives must be matched by stronger pressure for reform.
